- 2. The pre-bid meet is scheduled on **16.01.2019**, all vendors are requested to attend the pre bid meeting and clarify all their doubts about the specifications and the job. No queries and doubts will be entertained after the pre bid meeting on **16.01.2019**.
- 3. *The bank will place order as and when the requirement of these products will arise.*
- 4. All security products will be supplied with BIS label on it, with complete details as engraved by BIS
- 5. The bank reserves the right to accept/reject any/all offers without assigning any reason whatsoever
- 6. <u>The vendor shall make own arrangement for transportation & delivery of the equipment up to</u> <u>the given location-branch/office</u>
- 7. In case of any damage to the above items before handing over the equipment, the equipment is to be replaced or made good at the supplier expenses to the entire satisfaction of the Bank. In case of delay in rectification of defect, the bank shall be free to appoint another agency to get the job done at vendor's risk & cost.
- 8. At any point of time if it is observed that security product supplied by the vendor do not meet the standards of BIS or is sub-standard, bank will be at liberty to blacklist the vendor from supplying any

product to the bank in future.

- 9. The payment of the bills will be made by our respective office/branch, after satisfactory receipt of the goods.
- 10. The amount to be quoted in figures as well as in words. In case there is any variance in these two rates, the amount; written in words shall be taken as final;
- 11. All alterations in the tender should be initiated by the authorized signatory. Over writing may invite disqualification of the tender.
- 12. The rate quoted shall remain valid up to 31.01.2020. No escalation of in the rates will be allowed under any circumstances.
- 13. In case of any dispute, the matter will be referred to the General Manager, Gramin Bank of Aryavart. For litigation, if any arising thereof, the competent court (local) alone shall have jurisdiction.
- 14. Bank reserves the right to accept or reject any or all tender/s without assigning any reasons whatsoever and the said decision shall be final and binding upon the bidders.
- 15. The vendor agrees for random testing of their product bought by the bank at the current BIS test house at the cost of Vendor.
- 16. The Bank reserves its right to cancel the awarded work order at any time without assigning any reason what so ever.
- 17. The Bank reserves its right to penalize the vendor for delay in supply and installation of security equipments @ 10% per week from the billed amount.
- 18. The rates quoted by the vendor must be F.O.R. at branches, Regional offices, Head Office and other offices and branches in U.P. which may add in the bank in future.

The tender proposal should be submitted in a sealed envelope containing three sealed envelopes as per below details:

- iii. Duly signed complete tender proposal except financial bid.
- iv. Valid BIS Licenses for the products supplied, copy of the license must be enclosed.

- vi. OEM letter on the letter head from original locks manufacturers.
- vii. NOC to the bank for plant visit.
- viii. Copy of purchase order witnessing the supply of physical security equipments to scheduled banks in last four financial years i.e, 2014-15,2015-16,2017-18,2018-19.
- ix. Copy of purchase order witnessing the experience of minimum 10 years in supplying security equipments to the bank/financial institution.
- x. Copy of audited balance sheet of last three years reflecting the average annual turnover of Rs 10.00 crore in last three financial years.
- xi. Letter from the company to bear the cost of transportation and other charges involved in sending their installed products to the BIS lab.
- xii. Details of the authorized dealers and service centers in Uttar Pradesh and details of their godowns and ware houses in Uttar Pradesh.
